- [8] With regard to the follow up of the action taken on some of the resolutions adopted in the meeting of the High Powered Committee held on 3rd July, 2021, as per the discussion held during today's meeting the status of the same are as follows:-
 - (i) Whether sanitization of the cells in both the prisons is being carried out on alternate days and whether the same is healthy for the inmates, for which an inquiry was to be made by the Jail Authorities from the Health Department.
 - Status: It was informed by the Deputy Inspector General of Police (Prison), State Central Prison, Rongyek and Member, High Powered Committee that sanitization of the Prison is being conducted on fortnightly basis.

 The Senior Superintendent of Police (Prison), District Prison, Boomtar and Member, High Powered Committee informed that the process of sanitization is being carried out every day in the District Prison Boomtar, to which it was suggested by the Hon'ble Executive Chairperson that they should consult an expert and ascertain if the same is healthy for the inmates as it has been known that the chemicals used for sanitization could be carcinogenic. In the meanwhile it was suggested that sanitization process be done on fortnightly basis.
 - (ii) To consider the release of Convicts on furlough and remission, as per the Sikkim Prison Manual. The steps taken for remission of Convicts on 15th August, 2021 (Independence Day) as per the Operating Procedure laid down in Sikkim Prison Manual, 2010, and, whether a list for consideration for release of Convicts on furlough has been prepared within the parameters prescribed in the Sikkim Prison Manual to be placed for consideration in the meeting of the High Powered Committee.
 - Status: It was informed by the Principal Secretary, Home Department and Member, High Powered Committee that 72 prisoners have been granted Remission during the Independence Day Celebrations held on 15th August, 2021, which has been notified by Notification bearing No. 52/Home/2021 dated 13.08.2021, issued by the Home Department, Government of Sikkim and they would be eligible for Remission accordingly in terms of the Notification.

(iii) Whether the Jail Authorities have examined release of Convicts who have undergone sentence for 20 years in terms of the Sikkim Prison Manual.

Status: It was informed by the Deputy Inspector General of Police (Prison), State Central Prison, Rongyek and Member, High Powered Committee that there are no prisoners who have undergone sentence for 20 years in terms of the Sikkim Prison Manual.

(iv) Latest status with regard to procuring the Video Conferencing equipment by State Government for the two Prisons in Sikkim viz; State Central Prison, Rongyek, East Sikkim and District Prison, Namchi from the funds available with the Home Department.

Status

It was informed by the Principal Secretary, Home Department and Member, High Powered Committee that pursuant to the last meeting of the High Powered Committee held on 08.07.2021, the Home Department has requested the Finance Department, Government of Sikkim for providing budget for procuring Video Conferencing materials for the two Prisons (State Central Prison, Rongvek and District Prison, Boomtar). and that the matter would take some time. However, an of Rs.2.00.000/-(Rupees only, has been earmarked currently and the process of taking concurrence from the Information Technology Department and Finance Department is underway. He also informed that a vendor has also been identified for procuring the above materials ,and, that the entire process of procuring one VC equipment each for the two Prisons would be completed within one week.
